REPORT BY CHAIRMAN

I, S. Sandilya, the person appointed by the Hon'ble Court to act as Chairman of the meetings of the Secured Creditor, Unsecured Creditors and Equity Shareholders of the above named company, summoned by notice served individually upon them and by advertisement dated 11th February, 2015 published in Ahmedabad Editions of English daily "Indian Express", and "Divya Bhaskar", Gujarati Daily, and corrigendum dated 21st February 2015 published in Ahmedabad edition of Gujarati daily "Divya Bhaskar", for

a small typographical error and held on Thursday, 5th day of March, 2015 at 10:00 a.m., 10:30 a.m. and 12:00 noon respectively at H. T. Parekh Hall, First floor, Ahmedabad Management Association, AMA complex, ATRA, Dr. Vikram Sarabhai Marg, Ahmedabad, 380015, do hereby report as follows:

A. Meeting of the Secured Creditor:

- 1. The said meeting of the Secured Creditor was attended by 1 (One) Secured Creditor by proxy representing value aggregating to Rs. 1,68,47,030/- (Rupees One Crore Sixty Eight Lakhs Forty Seven Thousand and Thirty only) being the amount outstanding as on the date of meeting.
- 2. The proposed Scheme of Arrangement was taken as read with the permission of the sole Secured Creditor present at the said meeting. However, the salient features were explained by me to the sole Secured Creditor present, and detailed deliberations were made over the proposed Scheme of Arrangement. All questions raised by the sole Secured Creditor were replied to his satisfaction. After complete explanations of the Scheme and due deliberations, the question submitted to the said meeting was whether the sole Secured Creditor of the Demerged Company approved the proposed Scheme of Arrangement submitted to the meeting and agreed thereto.
- 3. The result of the voting upon the said question was as follows;
 - a) 1 (One) ballot representing value of Rs. 1,68,47,030/- (Rupees One Crore Sixty Eight Lakhs Forty Seven Thousand and Thirty only)was found to be cast.
 - b) No ballot was found to be invalid. Therefore, there was 1 (One) ballot representing value of Rs. 1,68,47,030/- (Rupees One Crore Sixty Eight Lakhs Forty Seven Thousand and Thirty only) found to be valid.

Thus, 1 (One) Secured Creditor of value Rs. 1,68,47,030/-(Rupees One Crore Sixty Eight Lakhs Forty Seven Thousand and Thirty only) constituting 100% in number and 100% in value, present and casting valid votes, voted in 'FAVOUR' of the Scheme.

B. Meeting of the Unsecured Creditors

- 1. The said meeting was attended by 7 (Seven) Unsecured Creditors, present either in person, or by proxy or through their authorized representatives representing value aggregating to Rs. 23,73,072/-(Rupees Twenty Three Lakhs Seventy Three Thousand and Seventy Two Only) being the amount outstanding as on the date of meeting.
- 2. The proposed Scheme of Arrangement was taken as read with the permission of the unsecured creditors present at the said meeting. However, the salient features were explained by me to the Unsecured Creditors present, and detailed deliberations were made over the proposed Scheme of Arrangement. All questions raised by the unsecured creditors were replied to the satisfaction of everyone. After complete explanations of the Scheme and due deliberations, the question submitted to the said meeting was whether the unsecured creditors of the Applicant Company approved the proposed Scheme of Arrangement submitted to the meeting and agreed thereto.
- 3. The result of the voting upon the said question was as follows:
 - a) Out of the 7 (Seven) votes cast, 1 (One) ballot was required to be treated as invalid as the value of the creditor's debt as on the date of the meeting was Rs. Nil.
 - b) The remaining 6 (Six) Unsecured Creditors present at the meeting and casting valid votes, aggregating to the total value of their debt at Rs. 23,73,072/- (Rupees Twenty Three Lakhs Seventy Three Thousand and Seventy Two Only) voted in favour of the said Scheme.

The under-mentioned Unsecured Creditors voted in favour of the proposed arrangement being adopted and carried into effect:-

- c) None of the Unsecured Creditors present at the meeting and casting valid votes voted against the said Scheme.
- d) Thus, the resolution approving the proposed Scheme of Arrangement was carried unanimously constituting 100% in number and 100% in value of the Unsecured Creditors present and casting valid votes at the said meeting.

C. Meeting of the Equity Shareholders

- 1. The said meeting was attended by 78 (Seventy Eight) Equity Shareholders, present either in person, or by proxy or through their authorized representatives representing total value of Rs. 6,46,05,970/- (Rupees Six Crores Forty Six Lakhs Five Thousand Nine Hundred and Seventy only) being the value of 1,29,21,194 (One Crore Twenty Nine Lakhs Twenty One Thousand One Hundred and Ninety Four only) equity shares having face value of Rs. 5/- each.
- 2. The proposed Scheme of Arrangement was taken as read with the permission of the Equity Shareholders present at the said meeting. However, the salient features were explained by me to the Equity Shareholders present, and detailed deliberations were made over the proposed Scheme of Arrangement. All questions raised by the shareholders were replied to the satisfaction of everyone. After complete explanations of the Scheme and due deliberations, the question submitted to the said meeting was whether the Equity Shareholders of the Applicant Company approved the proposed Scheme of Arrangement submitted to the meeting and agreed thereto.
- 3. The result of the voting upon the said question was as follows:
 - a) Out of the 84 (Eighty Four) ballot papers distributed to the Equity Shareholders present at the meeting and casting votes, 8 (Eight) ballots representing value of Rs. 91,550/- (Rupee Ninety One

Thousand Five Hundred and Fifty only) were not received back as the shareholders present abstained from voting. Since 3 (Three) shareholders having 9 (Nine) folios voted through 9 (Nine) ballot papers, they have been considered as only 3 (Three) votes / shareholders (and not 9 (Nine) votes / shareholders). However, the value of their shareholding is reflected based on the number of shares held by them for which they have cast their vote. Hence, there is a discrepancy between the number of shareholders and the ballot papers issued.

- b) Out of the balance 76 (Seventy Six) ballots cast, 1 (One) ballot representing value of Rs. 5/- (Rupees Five only) was required to be treated as invalid. The reason for treating the same as invalid is as provided by the scrutineer's report viz. due to signature mismatch.
- c) As mentioned above, since 3 (Three) shareholders having 9 (Nine) folios voted through 9 (Nine) ballot papers, they have been considered as only 3 (Three) votes / shareholders (and not 9 (Nine) votes / shareholders). However, the value of their shareholding is reflected based on the number of shares held by them for which they have cast their vote. Hence, there were remaining 69 (Sixty Nine) Equity Shareholders present at the meeting and casting valid votes representing value of Rs. 6,45,14,415/- (Rupees Six Crores Forty Five Lakhs Fourteen Thousand Four Hundred and Fifteen only).
- d) Of the above, 68 (Sixty Eight) Equity Shareholders aggregating to the total value of their shareholding of Rs. 6,45,14,410/- (Rupees Six Crores Forty Five Lakhs Fourteen Thousand Four Hundred and Ten only) voted in favour of the said Scheme.

The under-mentioned Equity Shareholders voted in favour of the proposed arrangement being adopted and carried into effect:-
