

## A. Annex C – Streamlined Energy & Carbon Reporting

## **Energy and Greenhouse Gas Report**

Mastek UK has appointed Carbon Footprint Ltd, a leading carbon and energy management company, to independently assess its Greenhouse Gas (GHG) emissions in accordance with the UK Government's 'Environmental Reporting Guidelines: Including Streamlined Energy and Carbon Reporting Guidance'.



The GHG emissions have been assessed following the GHG Protocol Corporate Standard and has used the 2021 emission conversion factors published by Department for Environment, Food and Rural Affairs (Defra) and the Department for Business, Energy & Industrial Strategy (BEIS). The assessment follows the dual reporting approach for assessing Scope 2 emissions from electricity usage, showing both location and market-based emissions. The operational control approach has been used.

The table below summarises the GHG emissions for reporting year: 1st April 2021 to 31st March 2022. As a business we have been assessing our carbon emissions since 2019, and have provided this year, last year's assessment results, and the baseline year's assessment results for comparison.
