'GLOBAL INTEGRATION HAS NOT BENEFITED EVERYONE EQUALLY' Trade wars result of erosion of trust in systems: IMF MD

RAVI DUTTA MISHRA New Delhi, April 18

TRADE TENSIONS ARE, to a large extent, the result of an erosion of trust in the international system and between countries as global integration — while lifting vast numbers out of poverty — has not benefited everyone equally, with many communities "hollowed out" by jobs moving overseas, said Kristalina Georgieva, managing director of the International Monetary Fund (IMF).

The impact of trade wars has begun to show up already in Indian sectors, which are facing steep duties on inputs such as steel and aluminium, as well as weak and below-expectation reported by IT earnings due to declining discretionary spending in the US. Several top software firms have even expressed uncertainty about wage hikes in FY26 amid tariff-related disruptions.

Such actions, if decisive enough, would lift confidence and domestic demand, help repair damaged trade relations, and set the stage for the next phase of China's growth story. Among other things, that story needs to include a stronger embrace of the natural progression from manufacturing to services as economies mature," she said.

Georgieva said the IMF has been advising China on policies to boost chronically low private consumption. These include scaling back industrial policies and widespread state involvement in industry, as well as strengthening social safety nets to reduce the need for precautionary savings.

through deepening the single market — would also help. "Europe needs a banking union, a capital markets union, and fewer restrictions on internal trade in services," she said.

Ultimately, trade is like water: when countries put up obstacles in the form of tariff and non-tariff barriers, the flow diverts. Some sectors in some countries may be flooded by cheap imports; others may see shortages. Trade continues, but disruptions incur costs," Georgieva said. That is an increasing worry for New Delhi.

Georgieva further said that countries must redouble efforts to put "their own houses in order" as, in a world of heightened uncertainty and frequent shocks, there is no time to delay reforms aimed at enhancing economic and financial stability and improving growth potential.

"Economies are confronting these new challenges from a weaker starting point, with public debt levels far higher than just a few years ago. Most countries must take resolute fiscal action to rebuild policy space, setting out gradual adjustment paths that respect fiscal frameworks. Some countries, however, may face shocks necessitating renewed fiscal support; if such support is required, it should be targeted and temporary," she said.

PM to visit Saudi next week; trade, energy, defence deals on the cards

PRIME MINISTER NARENDRA Modi is headed to Saudi Arabia next week — his first visit to the country in his third term. Since first assuming office in 2014, Modi has travelled there twice before — in 2016 and 2019.

Sources said that trade and investments, energy cooperation, reviving the IMEEC (India-Middle East-Europe Corridor) and defence partnership will be among the issues on the agenda for discussion when Modi visits the country on April 22-23.

Modi is expected to meet Crown Prince Mohammed bin Salman in Jeddah. His visit comes ahead of US President Donald Trump's expected visit to Saudi Arabia in mid-May — Trump's first foreign trip in his second term at the White House.

The visit comes at a time when the US is reaching out to Iran for talks to cap its nuclear programme, and Israel has been able to decimate Hamas and Hezbollah in the region.

The regional situation is still in turmoil, with the Houthis trying to disrupt maritime traffic on the Red Sea. India is keen to engage with Saudi Arabia and other partners in the region to restore stability.

The tension in the West Asian region has impacted the ambitious IMEEC in the last couple of years, ever since the

enhanced and comprehensive cooperation in political, economic, security and defence matters. Prince Mohammad bin Salman's visit to India in February 2019 carried forward this momentum.

Modi visited Riyadh again in October 2019, during which the Strategic Partnership Council Agreement was signed, establishing a high level council to steer India-Saudi ties. Prince Mohammed bin Salman then visited India in September 2023 to participate in the G20 Leaders' Summit and to co-chair the First Leaders' Meeting of the India-Saudi Arabia Strategic Partnership Council along with Modi.

Ties with Saudi Arabia are important for energy security — it was India's third largest crude and petroleum products sourcing destination in 2023-24.

October 7, 2023, terror attacks by Hamas on Israel led to the war in Gaza. New Delhi would want to take stock of the current situation, and move forward on the IMEEC — that will connect India with Europe, through the West Asia.

Saudi Arabia is a key partner in this endeavour and India wants to move on this swiftly, after high-level visits by the UAE's royalty, Israel's minister and Italy's deputy prime minister among others.

Digital overhaul in EPFO soon: Mandaviya

THE EMPLOYEES' PROVIDENT Fund Organisation (EPFO) is set to undergo a major digital overhaul to enhance services for over 90 million beneficiaries, with Version 3.0 set to launch by May or June, Union labour and employment minister Mansukh Mandaviya said

on Friday.

In coming days, EPFO beneficiaries will be able to withdraw funds from ATMs due to faster processing of claims on the newer Version 3.0, Mandaviya said.

"EPFO will soon implement Version 3.0 with the help of a robust IT platform to provide seamless and simplified services, including auto-claim settlements, digital cor-

rections, and ATM-based fund withdrawals. The overhaul is aimed at making EPFO accessible and efficient," he said.

According to Mandaviya, the new version will eliminate the need for complex and lengthy form-filling processes or physical visits for claims and corrections.

Beneficiaries will be able to update their EPFO accounts and mandates using OTP ver-

ification and conveniently monitor their pension entitlements or withdraw funds.

Due to fast settlement of claims, the funds would be quickly available in the subscriber's bank account, he added.

He said EPFO currently holds a corpus of ₹27 lakh crore with a sovereign guarantee and offers 8.25% interest.



Now GST registration within 7 days; 30 for risky biz

PRESS TRUST OF INDIA New Delhi, April 18

BUSINESSES WILL BE able to get GST registration within seven days, while applications flagged as risky will be processed within 30 days after physical verification of the premises.

Observing that some field officers are seeking various "unwarranted documents" by raising "presumptive queries", the CBIC gave an "indicative list" of the documents which officers can seek online from businesses.

"While processing registration application, query should not be raised by the officer seeking original physical copy of these documents," said the CBIC's revised instruction for granting GST registration.

The Central Board of Indirect Taxes and Customs (CBIC) said it has received complaints regarding difficulties being faced in getting a GST registration, mainly on account of nature of clarifications being sought by the officers and seeking of additional documents, which are not prescribed by the Board.
