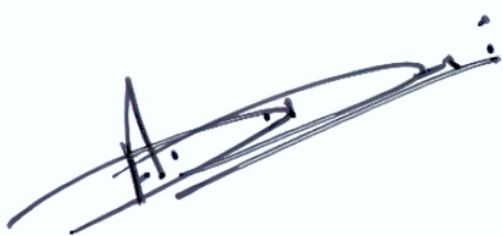
Mastek takes various steps to keep its employees, associates, partners and suppliers engaged and aware of various efforts taken towards Environment, Social and Workplace safety and betterment.
